

Event Planner

Please note that a wedding planner is required to orchestrate the arrangements for your special day. Our events team will work with you and your wedding planner to ensure that all of our resort services are in line with your requirements.

Open Flames

Please note that the use of an open flame is prohibited on the resort premises.

Guaranteed Attendance and Menu Selections

Though this number will not affect the Minimum Anticipated Food and Beverage Revenue figure noted in the packages, the final attendance for your function must be received in writing by the Event Manager no later than 30 working days before the date of the function. This will be the number for whom the resort will prepare food for the function. The resort cannot be responsible for service, accommodations or guaranteeing the same menu items for more than three percent over your guaranteed number of people. If a guarantee is not given to the resort by the specified date, the original estimated attendance would be considered the final guarantee. Your final menu selections must be made no later than 30 days prior to your arrival.

Taxes

Guestrooms: All prices, unless otherwise noted, are subject to 12% Service Charge, 11% VAT, and USD 3 Climate Resiliency Levy per room, per night. All food and beverages are subject to a 10% service charge (which is subject to 16% sales tax).

Force Majeure

No damages shall be due for a failure to perform where performance is made impossible due to acts of God, war, terrorist acts, government regulations, riots, disasters, or strikes. The resort shall have no liability for utility disruptions of any kind.

Deposit and Payment Requirements

A first deposit of 50% of the Minimum Anticipated Food and Beverage Revenue and Room Rental is due at the time of booking. Full prepayment for all charges must be received by the resort no later than 30 days prior to your event, in cash, or through our online credit card system. If such payment is not made, the resort may, at its option, deem the event to have

been cancelled by the client, in which case cancellation charges will apply as noted below and the resort will retain any deposits on hand and apply them to the cancellation charges. Interest will accrue on any unpaid balance or deposit paid late at the rate of 1.5% per month or 18% per annum.

Cancellation Policy

In the event of a cancellation occurring during the following time periods prior to the Event, liquidated damages in the following amounts will be due, plus applicable taxes and service charges.

- 0 to 90 days, ninety percent (90%) of Banquet Food and Beverage Revenue;
- 91 to 180 days, eighty percent (80%) of Banquet Food and Beverage Revenue;
- 181 to 365 days, seventy percent (70%) of Banquet Food and Beverage Revenue; and
- 366 or more days, fifty percent (50%) of Banquet Food and Beverage Revenue.

Marriage License Procedures

Licensed Wedding - St. Vincent & The Grenadines

Visitors who wish to marry in The Grenadines must be residents in St. Vincent and The Grenadines for one (1) clear day (the arrival day is not included) before attaining the marriage license. Upon arrival in Canouan, each guest is presented with a customs and immigration form. This form is needed as proof of residency when applying for the marriage license in St. Vincent.

The Governor General's License, which is a Special License, must be obtained at the Ministry of Justice, Kingstown, St. Vincent. Father Garraway is the preferred Justice of the Peace on Canouan to perform civil wedding ceremonies.

Applicants must produce their passports. Where an applicant was previously married, additional documentation is required.

A Marriage Officer, who has been duly appointed to perform such ceremonies, or the Register of the High Court, must perform the ceremony.

For those wishing to be married at our Canouan resort, the wedding documents must be filled out completely and brought to the minister of your choice.
